If received within 30 days of scheduled hunt date a \$5,000.00 cancellation fee will apply or \$1,500.00 transfer fee will apply to any bull elk package hunt.

The only exception will be in the case of death, verified illness or injury where written notification is provided by caring physician.

I promise to abide by all rules and regulations set forth by the Mescalero Apache Tribe while hunting on the Mescalero Apache reservation. I hereby acknowledge my participation in any hunt and due warrant that I am physically and mentally capable of being involved in the said activity, thereby accepting all claims herein on behalf of myself, I hereby release the Inn of the Mountain Gods and the Mescalero Apache Tribe from any injury arising from my participation in the above stated activity. Anyone under the age of 18 years old must present a certificate showing he/she has passed a hunter's safety course before receiving a hunting license.
